VEHICLE PARKING CONTRACT

I understand that parking my vehicle on school property is a privilege and know that I must obey all school, local municipality, and state laws in order to retain the privilege to park on school property. Specifically I understand:

1. A parking sticker must be purchased from the school and be properly displayed at all times.
Purchase of a permit does not guarantee a parking space.
2. I will park only in lots and spaces designated for student parking.
3. No student may obtain or attempt to obtain a parking permit under false pretense. By doing so, parking privileges may be removed for the remainder of the current school year.
4. My vehicle will not contain illegal substances such as alcohol, tobacco, drugs of any type or kind, stolen merchandise, etc. while parked on school property or at a school activity.
5. Under no circumstances will I have weapons of any type or kind in my vehicle while parked on school property or at a school activity.
6. School authorities have jurisdiction over my vehicle while it is on school property to the extent of (1) in my presence, search my vehicle for reasonable cause, and (2) within appropriate law, and seize improper materials found in my vehicle.
7. Maximum speed limit on school and district premises is ten miles per hour.
8. Vehicular traffic is limited to entering, parking, and exiting. No cruising or loitering will be permitted.
9. All vehicles are restricted to designated roadways. Motorized vehicles will not be driven on lawns, paths, or other prohibited areas.
10. No parking will be allowed in the areas where the curb is painted yellow, designated "NO PARKING" or where such parking would obstruct regular vehicular traffic.
11. Students shall not park in areas designated "FOR VISITORS or RESERVED."
12. Students are to park in the designated student parking areas and within parking spaces as directed by painted lines and signs.
13. Faculty and staff parking areas shall be designated, and students are not to park in these areas.

These rules and regulations shall be enforced by the appropriate area law enforcement agencies and authorized school personnel. Enforcement may include, but shall not be limited to the following citations, towing away at owners expense, and/or revocation of the privilege to park and drive on school property. School District #25 and Century High School assume NO responsibility for damage to cars, lost articles, damage to property or injury to persons by the automobile or its drivers while on school property.
